PROPERTY DESCRIPTION

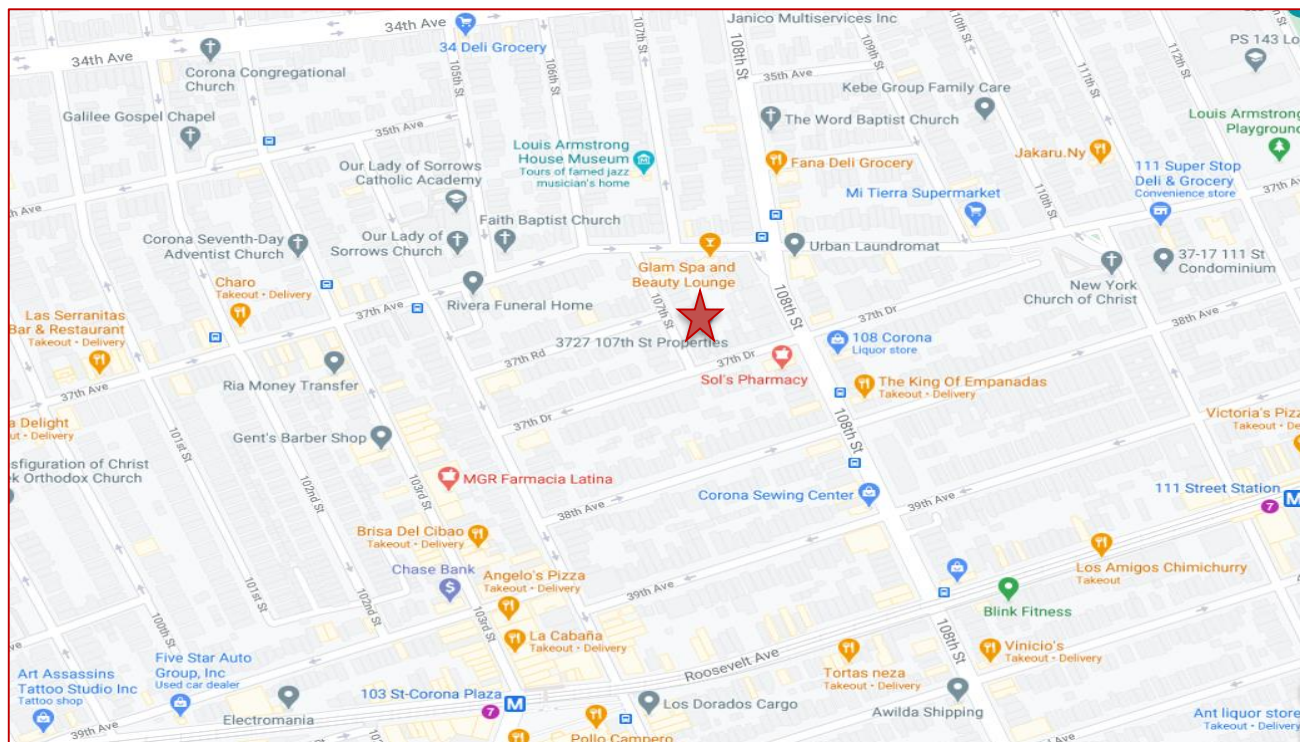

The building is 6,250 square feet and consists of 7 apartments. There are a total of (1) three bedroom apartments and (6) one bedroom apartments. This property is located in the central part of Corona and is walking distance to the main retail corridor of Roosevelt Avenue, equidistant between the 103rd Street Corona Plaza and 111th street stations. This location grants easy access to the 7 train, many shops and restaurants, and several MTA bus stops including the Q48, Q23, and Q66. The building has a 25 year tax abatement in place (expires 2037) and is individually metered for heat/AC, hot water and electric, presenting a perfect investment opportunity for an investor seeking a property in a high demand rental neighborhood that is not management intensive
